HOW IT WORKS

- Making a gift through your will or trust is very simple. It can be as easy as including language stating, “I give ten percent of the net value of my estate to “Knights Templar Eye Foundation, Inc.”
- Your gift can be a specific dollar amount or percentage of your estate. Or you can leave the Knights Templar Eye Foundation, Inc. the balance remaining after your obligations are met and your heirs are cared for.
- If you already have a will or estate plan in place, you can update it to include a gift to Knights Templar Eye Foundation, Inc. with a simple amendment called a codicil.
